# Highlights

- On average, all thresholds were greatly exceeded, but every threshold had some providers on the borderline
  - **Most popular** menu objectives: Drug formulary, incorporating lab test results & patient list
  - **Least popular** menu objectives: Medication reconciliation & summary of care record
- Little difference between Eligible Professionals (EP) & Hospitals
- Little difference among specialties in performance, but differences in exclusions



# Providers Included

- **2383 EPs had attested**
  - 2246 Successfully
  - 137 Unsuccessfully
- **100 Hospital had attested**
  - All successfully

**NOTE:** This data-only analysis shows our earliest adopters who have attested, but does not inform us on barriers to attestation.

Summary of care at transitions	88%	3%	82%
